XT Tax Removal on Electronic Ticket Display (TWD)

In accordance with the IATA resolutions, the Electronic Ticket Record (TWD) has been modified to display all the applicable taxes individually.

Effective 04th February, 2009, Amadeus System will not show the combined tax code 'XT' for transmission of Tax/Fee/Charge data in Electronic Ticket Records, Electronic Ticket displays (TWD). Instead, total of all the taxes will appear along with the base fare and the tax break up may be seen by performing the follow up entry TWD/TAX.

This applies for reissued tickets as well. The TWD display of a reissued ticket will show a single amount of all new taxes and for the break up of both paid as well as new taxes TWD/TAX can be performed.

Please note that there will be no change in the pricing output (FQQ) at FXP/FQP entries and XT tax code will continue to be displayed.

The XT tax code will only be removed from the e-ticket display (TWD). However, it will continue to be printed on the ITR.

A comparison of the old and new displays is detailed in the following pages.
